- e. Form SH- 14 (Change in Nomination)

Also take note it has been made mandatory for shareholders holding physical shares in the company to furnish PAN, KYC details and Nomination details. In the event our RTA doesn't receive the details as above by March 31, 2023, concerned shares shall be frozen by RTA.
